## **MESSAGE FROM NFID LEADERS**

We have faced many public health challenges in the US over the past year: measles outbreaks, waning vaccine confidence in some communities, and new survey data which found that many adults with chronic health conditions, and the healthcare professionals who treat them, are unaware of the increased risk of serious flu-related complications for those with diabetes, heart disease, and lung disease. But there also have been signs of hope: childhood and adolescent vaccination coverage in the US remains high for most vaccines and continues to improve for others; and research is ongoing to develop more effective vaccines and new vaccines to prevent infections due to other pathogens, as well as new approaches to managing drug-resistant infections.

Now more than ever, the mission of the National Foundation for Infectious Diseases (NFID) is vital to protecting public health. 



## **Leading Health Officials Urge Flu and Pneumococcal Vaccination**

NFID once again kicked off the 2018-2019 flu season at the 2018 Annual Influenza/Pneumococcal News Conference during which US Surgeon General Jerome M. Adams, MD, MPH, and then-Commissioner of Food and Drugs Scott Gottlieb, MD, joined leading health experts to discuss the importance of preventing flu and pneumococcal disease. A panel of national experts on pediatrics and obstetric care encouraged all individuals age 6 months and older to get vaccinated annually against flu. The panelists all led by example and received their flu vaccines at the news conference, which continues to attract significant media attention each year—earning more than 730 million media impressions in 2018.











# Call to Action: Dangers of Influenza and Benefits of Vaccination in Adults with Chronic Health Conditions

NFID issued an urgent Call to Action in September 2018 about the dangers of influenza (flu) infection among adults with chronic health conditions including heart disease, lung disease, and diabetes. The Call to Action also stressed the need for improved adult flu vaccination rates. Additionally, a new national survey conducted by NFID found that most US adults are not aware that individuals with certain chronic health conditions face a higher risk of flu-related complications, including an increased risk of heart attack and stroke.

## **#Outbreak: Epidemics in a Connected World**

NFID continued its support of the three-year Smithsonian exhibit, "Outbreak." On display at the National Museum of Natural History (NMNH) in Washington, DC until 2021, "Outbreak" examines the intricate network between humans, animals, their environments, and microbes—why infectious diseases emerge where they do, how they spread from animals to people, why some outbreaks become epidemics, and how people in different disciplines and countries are working together to stop them. The exhibit also addresses public fears and media hype head-on, empowering visitors to respond to future epidemics with knowledge and awareness. Visitors are invited to join epidemiologists, veterinarians, public health workers, and citizens of all ages and origins as they rush to identify and contain infectious disease outbreaks







## **Delivering Critical Messages about Preventing Hepatitis B Infection**

NFID launched a new initiative in November 2018 to reduce hepatitis B infections in the US by increasing hepatitis B vaccination rates in at-risk adults. Hepatitis B is a leading cause of liver cirrhosis and liver cancer. Nearly 30 years after the US adopted a public health strategy aimed at eliminating transmission of hepatitis B virus, adult immunization rates remain stagnant at 25 percent and new infections appear to be on the rise.

"Hepatitis B is an insidious virus. It can live silently inside us for decades, but all the while it is attacking the liver," says NFID Medical Director William Schaffner, MD. "It is only when serious damage is done that symptoms start and by then it can be very hard and often impossible to offer any meaningful treatment." The solution, according to the multidisciplinary group of experts who helped shape the initiative, is more widespread vaccination among at-risk US adults.





## Partnering with the Football Writers Association of America to Help #FightFlu

NFID and the **Football Writers Association of America** joined forces in July 2018 to present the annual Outland Trophy as part of a continued public awareness campaign focused on the importance of influenza (flu) prevention. Selected by FWAA, the trophy is awarded annually to the top interior lineman in college football. The program reinforces annual vaccination as the best line of defense against flu.

"The partnership with the Outland Trophy offers NFID a timely opportunity to promote the importance of flu prevention and reminds college football fans all across the US that annual flu vaccination is recommended for all individuals age 6 months and older," said NFID Executive Director & CEO, Marla Dalton, CAE. "With millions of college football fans congregating at stadiums and tailgate parties every weekend, it is critical for everyone to get vaccinated to protect themselves and each other."


